# Reaching the Oz of Safety and Quality

During his first year in college, Peter Pronovost's parents visited him with terrible news: his father's cancer diagnosis. Over his undergraduate years, Pronovost stood by his father's side for the treatments and services involved in the final years of his life. But as Pronovost describes in his book, *Safe Patients, Smart Hospitals: How One Doctor's Checklist Can Help Us Change Health Care from the Inside Out*, medical errors intensified his father's suffering and likely cut short the few weeks or years he had left.

Subsequently, Pronovost attended one of the best medical schools in the United States, Johns Hopkins. His promising future in medicine lay ahead like the yellow brick road, with every opportunity to achieve the heights of success in medicine. And like Dorothy, when his pathway in life finally brought him before the Wizard, he did something unexpected: He paid attention to that man behind the curtain. Pronovost chose to dedicate his career to ending the errors, accidents, and infections that happen behind the scenes, and too often hurt the patients clinicians are trying to help.

Today Dr. Peter Pronovost is one of the most respected and influential physician leaders in the United States, head of the Armstrong Institute for Patient Safety and Quality at Johns Hopkins Medicine. His contributions to healthcare are disarmingly simple yet profound. Surgeons should run through checklists before putting knife to skin. Hospitals should enforce rigid protocols for inserting central lines to prevent infections. Today there is a significant body of research on how hospitals and clinicians can avert common mistakes and problems.

Unfortunately, thousands of people are still suffering and dying from preventable errors and infections every day in American hospitals. Why? It's not for lack of knowledge; the research gives clear instructions on keeping patients safe, and according to Leapfrog data and our Hospital Safety Score, hundreds of hospitals demonstrate it can be done. It's not for lack of resources either. Many Leapfrog Top Hospitals and high-performing Hospital Safety Score hospitals serve indigent populations and watch every penny, while more hazardous hospitals bask in large endowments. The highest-scoring hospitals come in all sizes and shapes, rural and urban, teaching and community, large and small.





The problem is motivation; heart and courage to apply the knowledge we already possess. Some hospitals simply don't make safety or quality their priority. Patients themselves don't often create a market for safety, mostly because they don't know to discern the relative safety of a hospital or insist on precautions once they are admitted. Few health plans base contracts with hospitals primarily on safety performance, though that is changing. Even though employers and other purchasers created Leapfrog and hundreds use it ever year, still they do not yet exert adequate market pressure for safety.

But the facts are revealed in the data: Some hospitals are much safer than others, and some are higher quality. Patients deserve to know which is which, so they can protect themselves and their families and at the same time drive a market for safety. That is why this year Leapfrog sought the advice of Peter Pronovost and eight other leading national researchers to create the Hospital Safety Score, a letter grade rating the safety of general hospitals across the country. It's designed to be accessible to consumers.

Today we are pleased that Dr. Pronovost is the closing keynote for The Leapfrog Group Annual Meeting, where he will remind us that the highest standards of patient safety are achievable by motivated hospitals.

We also welcome keynote speaker Regina Holliday. Like Peter, Regina's journey in health care was transformed by tragedy, the suffering and death of her late husband. Her vision for Oz: a world where hospital transparency is the norm. She will share that inspiring vision with us and encourage us to join her on her yellow brick road.

The Leapfrog Annual Meeting brings together our top hospitals and our purchaser members to celebrate excellence in hospital quality and safety, and rededicate ourselves to elevating the standards for healthcare in every community in America. Our board and membership are always inspired by the example of our Top Hospitals, which remind us that purchasers can and should expect the best for our employees and the public.

The problems in hospital quality and safety are significant. The good news is they are solvable. Like Dorothy's three traveling companions in Oz, we already have the brains, heart and courage to make a difference—we just have to apply them all together for optimal effect.

### Keynote Speakers




